

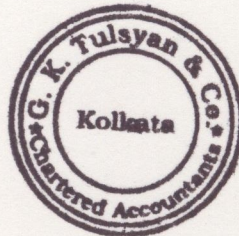


Review Report to **M/S GMB CERAMICS LIMITED**


